Installation

This camera series shares a similar structure. We take one type among this series for demonstration.

You need to prepare waterproof tapes before installation.

Make sure the device is firmly secured to any wall or ceiling mountings.

Be sure that there is enough space to install the device and accessories.

Make sure that the device in the package is in good condition and all the assembly parts are included.

Make sure that the wall is strong enough to withstand at least 4 times the weight of the device and the mount.

Make sure that the power has been disconnected before you wire, install, or disassemble the device.

Make sure that no reflective surface is too close to the device lens. The IR light from the device may reflect back into the lens causing reflection.


